## THE ENVIRONMENTAL COMMISSION OF TRINIDAD AND TOBAGO

**COVID-19 VIRUS EMERGENCY DIRECTIONS**

This Practice Direction is issued pursuant to Rule 1.5 of the Environmental Commission's Rules of Practice and Procedure 135/2002 in light of the novel Covid-19 virus.

The Environmental Commission of Trinidad and Tobago (referred to as "Court" hereafter) is very conscious of the Covid-19 pandemic facing us. Given that there is no known cure available at this time, the virus poses a very serious threat to all of us in Trinidad and Tobago.

WHEREAS the Court remains committed to ensuring that there is the continued access to justice for all, while at the same time ensuring the safety and protection of its staff as well as the public; and

WHEREAS the Court assures the public that it remains committed to its judicial mandate and looks forward to doing its part to ensure that the Republic of Trinidad and Tobago overcomes this difficult period; and

WHEREAS the Environmental Commission wishes to:

- (a) Prevent the spread of the Covid-19 virus;
- (b) Reduce the number of persons coming to the Environmental Commission;
- (c) Minimize the opportunity for contact between its staff and the public;
- (d) Keep its courtroom, registry and offices as safe as possible for those who must be physically present;
- (e) Implement a system of work from home for staff whose physical presence is not absolutely necessary for the performance of his/her function;

THE ENVIRONMENTAL COMMISSION OF TRINIDAD AND TOBAGO  
COVID-19 VIRUS EMERGENCY DIRECTIONS—Continued

The following measures have been implemented from Tuesday 17<sup>th</sup> March, 2020 and will continue until further notice:

**1. FILINGS**

Effective immediately all filings are suspended save for filings in matters deemed fit for hearing during this period and/or in support of applications to have matters deemed fit for urgent hearing during this period;

**2. CASE MANAGEMENT**

Effective immediately the Court shall not be conducting any Case Management Conferences until further notice.

**3. MEDIATION**

Effective immediately, the Court will not be fixing any mediation proceedings and any on-going mediation proceedings will be suspended until further notice.

**4. DEEMING MATTERS FIT FOR HEARING DURING THIS PERIOD**

- a) The Court may, on its own motion, deem a matter fit for hearing during this period;
- b) Any party to an action or to an intended action may apply to the Court to have a matter deemed fit for hearing during this period. An application for an interlocutory injunction would qualify as a matter fit for hearing during this period;
- c) Any application under paragraph (b) must be made in writing to the Registrar of the Court AND must be accompanied by an affidavit setting out the facts and reasons which make the matter fit for hearing in this period;
- d) The Court's Registry remains open to accommodate filings under this heading during this period.

**5. TIME**

For the duration of this Practice Direction, time will cease to run in respect of all directions or deadlines not specifically dealt with.

**6. BAILIFFS**

Effectively immediately, the serving of documents, orders and notices of the Court by Bailiffs are suspended until further notice.

**7. LIBRARY**

Effective immediately the services of the Court's library to attorneys and members of the public are suspended until further notice.

**8. OTHER MATTERS**

- a) In the interest of public health and safety and in order to maintain the appropriate social distancing, attendance at the Court's facilities should be limited to attorneys, parties, and necessary witnesses. Persons who are not directly involved in the matter will not be allowed entry into the Court;
- b) The Court has established screening procedures and health and safety protocols for entry into the court offices. Persons may be denied entry into the court offices if they display flu-like symptoms related to Covid-19 or otherwise fail to meet the screening standards required for entry to the Court; and
- c) Anyone with legitimate court business who is carrying Covid-19, is caring for someone who is so infected or in a high-risk category as stated by the Ministry of Health, is advised as follows:
  - i) to remain at home; and
  - ii) to request an adjournment via e-mail to the Registrar of the Court at [antoinette.alleyne@ec.gov.tt](mailto:antoinette.alleyne@ec.gov.tt) or contact the Court via telephone at (868) 625-7353; 627-9186/3432 or fax at (868) 627-0871.
